
























Our People




The Bat House: Completed Feb 2015

Closed during demolition



Site Traffic

- Site Speed limit 5mph.
- All vehicles will use Cypress Avenue other than where the vehicles are too large to negotiate the Cypress avenue railway bridge.
- No permitted use of Beach road between 0800 0930 and 1500-1630, and again only if too large to negotiate the Cypress avenue railway bridge.
- Site traffic will be scheduled to avoid pick up times of school children at the local school and local church services.
- Car share for construction personnel will be coordinated, no site parking in top Car Park or on local roads.
